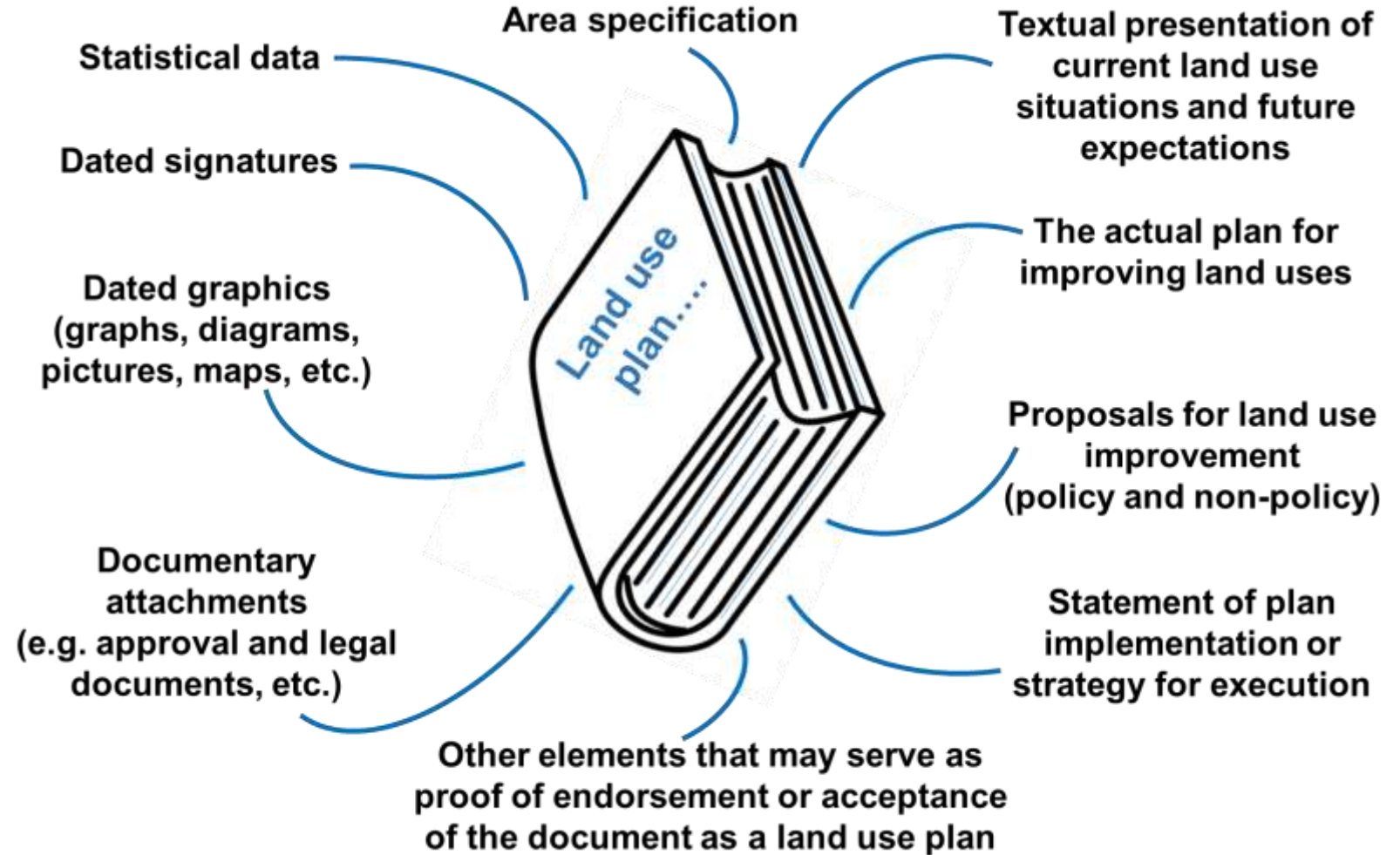

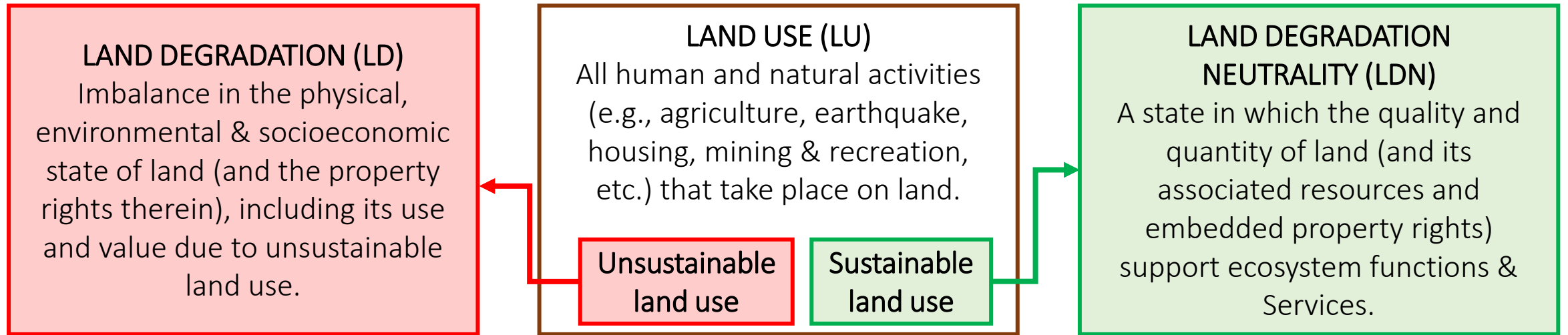

Tenure responsive land use planning (LUP) ensures that tenure is inbuilt in LUP processes so that the design life and strategies are fixed for long term tenure security conditions through appropriate land use decisions, human behaviours (including attitudes and values) and activities.

## Tenure responsive land use planning and land degradation neutrality relationship

### TENURE RESPONSIVE LAND USE PLANNING (TR-LUP)

A culmination of all activities and decisions concerned with guiding the allocation of, and use of land in patterns that enable improvements in people's way of living and their Environment.

Sustainable land use

Conscious efforts to re/structure land uses, rules (land tenure) and activities (development) on land to avoid, reduce and reverse degradation.

### LAND DEGRADATION NEUTRALITY (LDN)

A state in which the quality and quantity of land (and its associated resources and embedded property rights) support ecosystem functions & Services.

### Produce LUP Impact on Communities

- Functional rules guiding land use, tenure security and ecosystem services.
- Secures tenure on land uses and people's living conditions that avoid, reduce & reverse LD.



Document & record land rights & exercise of bundle of rights, restrictions & responsibilities to avoid, reduce & reverse LD.

### Implementation of Tenure Responsive and Participatory Integrated Land Use Planning

- Produce land-use plan that supports clearer physical, social tenure boundaries.
- Promote exercise of land rights for quality and quantity of land that support ecosystem functions & services.

(Re)Structure modes of accessing, holding, owning & exercising land rights following rules & activities for avoiding, reducing & reversing LD.
